DOSAGE

RESIKON LWP should be used in the range of 250-350 ml per bag of cement. Actual dosage should be ascertained at site by conducting trials with the materials to be used.

Around 10% of water can be reduced when RESIKON LWP is used at higher dosage

Add RESIKON LWP to the gauging water and then mix with cement aggregate mixture. Do not add RESIKON LWP directly to the cement.

STORAGE	Twelve months when stored in sealed containers under shade.
